This product is one of the personal protective equipment whose basic function is to protect the feet from injuries that may occur in accidents in the work areas for which it is intended. It is specially made as footwear for firefighters, resistant to the risks associated with extinguishing fires and concurrently resistant to cutting by a chainsaw. The footwear is equipped by a toe caps for the finger protection and provides impact protection at an impact energy of 200 J and against compression at a buoyancy force of 15 kN. The footwear fulfills requirements **EN 15090:2012** with additional requirements for cold and water resistance. In terms of heat insulation, it meets the requirement for HI3, in terms of electrical properties, it is an antistatic footwear. According the technical standard mentioned above, these are footwear for firefighters type 2, marked F2A. The tested footwear meets the requirement according the standard **EN ISO 20345:2011** for slip resistance SRC. Concurrently meets the requirements according the standard **EN ISO 17249:2013, EN ISO 17249:2013/AC:2014-02** for footwear resistant to cutting by a chainsaw, level 1, in terms of shape, construction and resistance to cutting by a chain saw.
